3. The Principals and Directors of the concerned colleges are instructed to conduct all SPPU-level practical and project examinations under **the Faculty of Interdisciplinary Studies** internally. This arrangement will remain in place until a formal Standard Operating Procedure (SOP) is issued by the university.
