Now the next meeting of the committee is scheduled to be held on 24/03/2018 at 11:00 am in the office of the University and you have been provided one more opportunity to appear before the said Committee in your defence on the day, time and place fixed for the meeting, along with your written explanation (as per the enclosed format) to the above referred Show Cause Notice.

You should also bring your examination Hall Ticket and College Identity Card. If you fail to appear before Committee, it will be presumed that you have nothing to say in this matter and the Committee will take decision in your case in absentia, on the basis of the available evidence/documents, which shall be binding on you.
